The European ESG Template (EET) - the European standard for the exchange of securitiesrelated ESG data. Get smooth access to this important data via WM Datenservice and use it to meet your regulatory requirements and optimise your processes.

The so-called European ESG Template (EET) was developed by the European FinDatEx working group for data communication and data exchange in the ESG context. The template is populated by product manufacturers - in particular fund companies and issuers of structured products - at instrument level. Users of the EET and the data made available via it are primarily insurance companies, banks and fund of funds managers. The EET has been in use since mid-2022 and has since developed into the European standard for the exchange of securities-related ESG data.

Version 1.1.2 of the EET comprises a total of 616 data points. Among other things, this information supports data users in meeting the constantly increasing regulatory requirements for financial instruments in terms of ESG information.

# **Areas of application**

The content of the EET data points refers to obligations arising from the Sustainable Finance Disclosure Regulation (SFDR), Taxonomy Regulation, MiFID II and Insurance Distribution Directive (IDD) and are required by market participants in various use cases.
